

Terms & Conditions

Skip Hire

Should Sixtowns Waste or a 3rd party acting on its behalf be unable to deliver or collect a skip due to access issues there will be a wasted journey charge of a minimum of £85 +vat issued*.

Sixtowns Waste may also at its discretion apply a wasted journey charge for any cancellations issued within a 24h period during its normal operating hours.

Skips should be filled level with the sides, should the skip be overloaded the skip will not be collected and a wasted journey charge will be applied.

Non-account skips will not be collected until payment has been received in full unless agreed in advance.

Prices are based on you providing an accurate description of your waste. Should any hazardous or restricted items be found in the skip you will be charged for their disposal at the current rate and an administration fee of £35 +vat issued.

Any contamination found in wood/inert/plasterboard/metal only skips will result in general waste charges and an administration fee of £35 +vat issued.

Terms & Conditions

Unless otherwise agreed in advance the hire period is 14 days, there will be a charge of £45 +vat per week issued after this. This includes if Sixtowns Waste or a 3rd party acting on its behalf is unable to collect the skip due to overloading, access issues, not receiving the initial hire payment or being unable to contact you.

Under no circumstances are the following to be put in the skip:

Asbestos, fridges, freezers, batteries, gas canisters, paint tins, fluorescent tubes, aerosols, hazardous materials, chemicals, liquids, telegraph poles, railway sleepers or creosote treated timber.

If you do need to dispose of these items, our waste clearance team can assist.

Please inform us if you intend to put the following items in the skip as it may affect the price:

Upholstered furniture, plasterboard, mattresses, any electrical or electronic equipment, black polythene, astroturf, tree roots/stumps, carpet, vinyl, rubber matting or roof felt.

Any contamination found in wood/inert/plasterboard skips will result in general waste charges.

Terms & Conditions

Waste Collection & House Clearance

All quotations are based on the waste description you have provided, any waste that is not as described will not be collected.

Should any hazardous or restricted items be found mixed in your waste you will be charged for their disposal at the current rate and an administration fee of £75 +vat issued.

Sixtowns Waste or any 3rd party acting on their behalf shall not be held responsible for any items taken by mistake unless reasonable measures have been taken to make it clear they are to stay.

This could include telling us or separating the items from the waste to make it clear and obvious they are to stay.

Should Sixtowns Waste or a 3rd party acting on its behalf be unable to attend site due to access issues there will be a wasted journey charge of a minimum of £45 +vat issued*.

Sixtowns Waste may also at its discretion apply a wasted journey charge for any cancellations issued within a 24h period during its normal operating hours.

Terms & Conditions

Grab/Tipper Hire & Aggregate Supply

Should Sixtowns Waste or a 3rd party acting on its behalf be unable to complete the works to access issues there will be a wasted journey charge minimum of £85 +vat issued*.

Sixtowns Waste may also at its discretion apply a wasted journey charge for any cancellations issued within a 24h period during its normal operating hours.

Prices are based on you providing an accurate description of your waste. Should any hazardous or restricted items be found you will be charged for their disposal at the current rate and an administration fee of £35 +vat issued. If we are not able to collect the waste due to contamination a wasted journey fee will be applied.

Hazardous Waste Removal & WEEE Recycling

All quotations are based on the description of waste provided by you and assumes that any sample is an accurate representation of the waste stream. It is the waste producer's legal responsibility to verify that the information supplied and recorded by Sixtowns Waste Ltd herein is accurate and correct.

The haulage and loading rate includes up to 30 minutes on site, additional time on site will be chargeable at a rate of £50.00 per 30 minutes thereafter.

If both parties have agreed a collection date and the collection fails through no fault of Sixtowns Waste Ltd (IE unable to access waste, waste in poor transportable condition) We reserve the right to charge a failed transport cost which will be equal to the transport rate quoted.
